Do your students struggle with persistence and goal attainment? Do you ever wonder how to retain them long enough to build employability skills, not just get a job? Since 1989, the National Center for Families Learning has advocated intergenerational programming as a way to break the cycle of poverty. This approach validates the adult student as a learner, parent or family member, and valuable asset in the community. In this session, we will provide an overview of NCFL's program models, including strategies for implementation, observed outcomes, and direct connections to workforce development.

### **Competency-Based Adult Education: What It Is and How It Promotes Personalized Learning Advancement for Adult Student to ACH**

Competency-based education (CBE) offers instructional and assessment strategies and features that encourage learners at all levels to stay motivated to reach mastery, bridge gaps, improve college and career readiness, and become independent in the learning process. This presentation explores Competency-based education, its past, and its application in current adult education. The presentation will examine the current effort underway to create a competency-based approach using research-proven instructional and assessment strategies for adult education. It will examine how CBE employs strategies that personalize learning for all levels and across all content areas.

**Blended Learning: What Does this Instructional Model Look Like in ABE?**

Blended learning combines classroom instruction and learners working independently with digital media. Practitioners are uncertain about what blended actually looks like in adult learning. NRS Implementation Guidelines frame blended as a complement to distance learning, so ABE programs might conceptualize blended as a spin-off of it, as opposed to an opportunity to support personalized learning both in and out of the classroom. This session reviews relevant research and models of blended learning in ABE contexts (Murphy et al., 2017; Rosen & Stewart, 2015) and describes examples used across the U.S. Participants will leave the session with ideas to support personalized and accelerated learning and flexible models for classroom instruction as part of blended learning.

**Effectively Working with Data in Adult Education Programs**

Analyzing and utilizing program data can be an effective means of identifying areas of improvement and conducting research on program design elements and student outcomes. To ensure that program data and analysis are valuable, it is imperative that program administrators and educators follow basic quality assurance practices at all times and have a clear understanding of their data and how it might be used. This presentation will provide guidance that is relevant to a range of adult education programs by describing and discussing the types of data that are common to adult programs, reviewing best practices for working with data in this context, and providing illustrative examples from existing programs.

**Effective Citizenship Education Programs: Quality Indicators and Best Practices**

2017 has seen an increase in the number of immigrants applying to become naturalized U.S. citizens. As a result, many adult education providers are starting or expanding citizenship education programming. What makes a citizenship education program effective? How can adult educators prepare immigrants to successfully navigate the high stakes USCIS naturalization interview and pass the naturalization tests? This session will begin with a brief overview of the U.S. naturalization process. The presenter will then summarize the content knowledge and language skills needed to pass the USCIS interview and tests. Best practices in the areas of curriculum design, instruction, and assessment for quality citizenship education programming will be shared.

The aim of this session is to provide inspiration and models for participants as one plans or strengthens their own IET programs by exploring the guide's key themes: the role of context in determining the direction and design of one's program, the kinds of supports that are needed (policy and services), and ways of engaging employers.
